Investments – The following summaries are excerpted from the three advisor reports as of the end of August. Market stability had appeared to be slowly returning but some backsliding has recently taken place. A goodly fraction of above-average 2020 and 2021 gains have been eroded. Sufficient portfolio assets are withdrawn for office needs as required including \$20,000 from KC in August. As of this writing total liquid assets held in our portfolios is apprx. \$2.2 million. Let me know what you think. All advisor summaries are year-to-date.

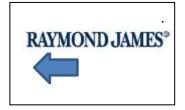
