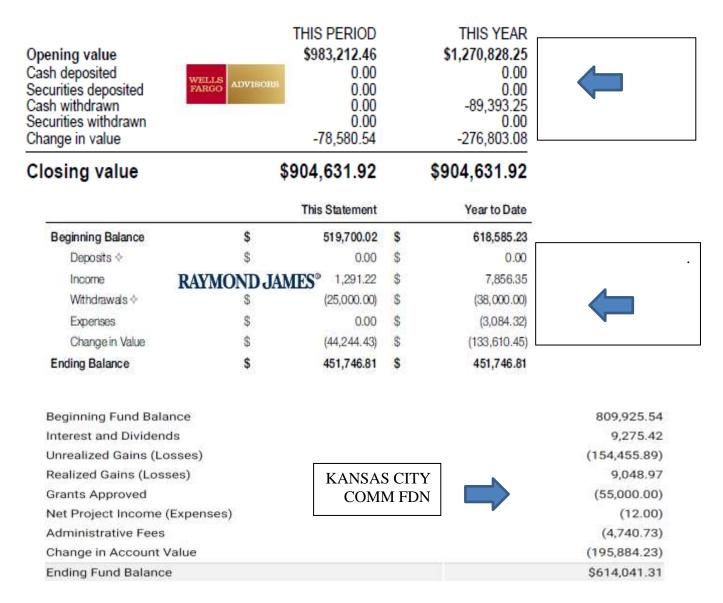

<a href="mailto:Investments">Investments</a> – The following summaries are excerpted from the three advisor reports as of the end of September. A goodly fraction of above-average 2020 and 2021 gains have been eroded. Sufficient portfolio assets are withdrawn for office needs as required. As of this writing total liquid assets held in our portfolios is down to apprx. \$2 million as the result of working capital draws and portfolio value shrinkage. Interestingly while capital markets have suffered significant value decline few, if any, have over-reacted. It feels like a "stay the course" mood. Let me know what you think. All advisor summaries are year-to-date.
